Our COVID-19 Response Efforts

CQC's mission is to advance quality and efficiency throughout California's health care delivery system. Our programs continue to actively support ambulatory care organizations and primary care practices as they struggle with unprecedented challenges, including the threats of revenue loss and practice closure, while responding to the COVID-19 crisis.

We are leveraging CQC's team and expertise, experience, relationships, and resources for COVID-19 support efforts that accelerate practice transformation and advanced primary care, including behavioral health integration and payment reform, to help providers meet their patients' immediate and future needs.

For the greatest impact, CQC is:

- Brokering technical assistance and resources for adoption of sustainable virtual care models to provide patient-centered care under both fee-for-service and reformed payment models;
- Targeting support for IPAs and small and independent practices, which are under-resourced, financially insecure, over-burdened with high risk populations, and without other support groups within the state;
- Adapting in-person technical assistance offerings into virtual trainings and improvement collaboratives;
- Advancing value-based payment reform for primary care.

PBGH developed tools and resource materials to promote the adoption of certified nurse-midwives (CNMs) in California.

Small practices and IPAs have made remarkable progress implementing and expanding telehealth in a very short timeframe, providing critical care to their patients. To support these providers as they adopt virtual care, CQC has been hosting bi-weekly webinars since the end of March, including sessions with peers sharing telehealth implementation experience, lessons from a successful "virtual-first" primary care practice and billing guidance for submitting telehealth and virtual care claims.
