Honoring Front Line Workers

As the public health emergency continues, the California Quality Collaborative team salutes our health care provider partners working on the front lines to provide safe, high-quality and patient-centered care under incredibly difficult circumstances. We're honored to share opportunities and resources that can further improve and strengthen health care quality in California during this challenging time.

Program Highlights

In October, CQC launched our latest improvement collaborative, the CalHIVE Network. The collaborative will engage seven provider organizations throughout the Central Valley and Inland Empire to improve care for patients with asthma and diabetes. CalHIVE's curriculum will focus on chronic disease management provided virtually.

CalHIVE kicked off with a needs assessment conducted by each organization's improvement advisor. As the collaborative's learning activities are all virtual for now, we are designing a mix of live webinars, curated tools and resources to support our first focus area, which is telehealth operations. Finally, our data team has been analyzing the first cycle of provider performance measurement data for the key metrics we'll be improving on as a cohort.

Midwifery Initiatives

PBGH developed tools and resource materials to promote the adoption of certified nurse-midwives in In 2020, CQC launched two webinar series to spark transformation across the delivery system:

- The <u>Resilient Primary Care</u> series covers topics improving the foundation of high-performing primary care as well as innovations that will bolster practices as they adapt for the future. This year we <u>reviewed challenges and</u> <u>opportunities in sustaining virtual chronic care</u> and a framework for <u>primary and maternity</u> <u>care integration</u>.
- The <u>Accelerating Integrated Care</u> series highlights provider organizations' progress integrating behavioral health into primary care, now even more essential as patients' mental health needs increase. We hosted sessions that <u>spotlighted case studies from providers</u> <u>effectively integrating care and payment</u>, and a <u>deep-dive on patient perspectives around</u> <u>screening</u>.

Designing Responsive Telehealth Support

In response to COVID-19, CQC hosted bi-weekly webinars between the end of March and June supporting primary care practices rapidly implementing and optimizing telehealth to care for patients unable to be seen in-person during the pandemic. In this blog post, we synthesized our learnings around what providers and patients want in telehealth, and how technical assistance organizations can best support the transition to seamless virtual care.

California. Integrating midwives into practices and hospital deliveries can lower the total cost of care. When physicians and midwives practice collaboratively, childbirth becomes less medicalized and has fewer interventions (fewer Csections, inductions, epidurals). Midwifery-led care and physician-midwife collaborative practices also drive higher quality scores (e.g. higher rates of breastfeeding).

Midwifery Resources

Telehealth and virtual care adoption skyrocketed in 2020, but many health care providers and provider organizations implemented technology quickly and haven't incorporated virtual care into their strategic roadmap.
