Thank you to all teams for completing
your Cycle 2 Global Reporting
Measurement Data Submissions. The
[CalHIVE BHI Tableau Performance
Dashboard](#) has been updated to include
measurement data from Cycle 2 (April to
June 2024) and unblinding of your peers'
measure performance. We encourage you
to find new insights and understand how
your measure performance is changing
over time, determine relative and absolute
change needed to achieve an internal or
external benchmark and compare your

measure performance with your peers in CalHIVE BHI.

Jose will continue to join improvement advisor meetings in November to discuss your pilot site finance and process measures and identify opportunities to optimize your measures' specifications to support the tracking of your BHI implementation efforts. After meeting with Jose, a deadline will be provided to your team to re-submit a final draft of your measures' specifications. Reporting for the pilot site will begin on Cycle 3 (January 2025).
